### Pergolide Paste

This medicine has been prescribed or given for your horse or donkey. It is not a licensed medicine and is provided as a 'Special Veterinary Medicine' meaning that it has been formulated under strict production controls to ensure purity of the product.

**What is pergolide?** Pergolide blocks dopamine receptors in the brain reducing excessive production of other hormones and mediators. It is used in the treatment of equine pituitary pars intermedia dysfunction (PPID) or "Equine Cushing's Syndrome".

#### **Why has my horse been prescribed pergolide paste?**

Pergolide reduces the production of hormones and mediators which cause the signs of PPID or "Equine Cushing's Syndrome", including laminitis.

#### **How should I store and handle pergolide paste?**

For safety all medicines should be kept out of reach and sight of children. There are no special storage requirements.

**What should I do if I run out of pergolide paste?** It is likely that use of pergolide paste will be a long-term treatment so contact your vet with plenty of time if you require more supplied. If you run out then tell your vet and resume treatment as they recommend.

**What should I do if I accidentally overdose my horse?** Contact your vet. Clinical signs of pergolide overdose include inappetence, lethargy and behavioural changes.

**What should I do if I miss a dose?** If a dose is missed just give the next dose at the normal time. DO NOT give a double dose to make up for the missed dose.

**If my horse is better, what should I do with the remaining medicine?** As with all medications, it is important that the full course is completed. You should contact your veterinary surgeon before changing the dose or stopping the medication. Pergolide is most commonly prescribed as an ongoing/ life-long treatment.

**If my horse is not improving, what should I do?** Contact your veterinary surgeon who will review whether this is the correct medication for your horse.

**Can my horse take pergolide paste alongside other medication?** Tell your vet if you are giving your horse any other medicines.

**What do I need to record in my horse's passport?** This medicine is not marketed for use in horses intended for human consumption. However current legislation allows it to be used in such horses without the need for residue limits. If your horse has not been excluded from the human food chain, you must keep a record of its use.

**What are the possible side effects of pergolide in my horse?** Pergolide side effects include inappetence, lethargy and behavioural changes. **If you observe any side effects, stop administering the medication immediately and contact your vet.**

#### **What should I do if a person accidentally takes this medicine?**

If a person accidentally takes this medicine, you should contact NHS direct (telephone 111) or take the person to a

local hospital taking this leaflet and the syringe with you.



**The prescribing cascade:** This medicine is authorised for use in human patients or other animal species and is used by vets under the 'prescribing cascade'. Your vet can explain this in further detail and explain why they are prescribing this drug for your horse. If you do not agree to the use of this medicine in your horse you should discuss this before administration.
