Failure to do so may result in unnecessary delays in processing your certificate.***

By completing this form, you understand and agree that:

- An Animal Health Certificate (AHC) is for non-commercial travel of pets only. (i.e. no sales or change of ownership of pets are allowed)
- If you are not personally travelling with your pet, you must complete a separate declaration and be reunited with your pet within 5 days.
- No more than 5 pets can travel on one certificate.
- Travel is to European Union (EU) countries only.
- Once signed, the certificate is only valid for: 10 days for entry into the EU or Northern Ireland; 4 months for onward travel within the EU; and 4 months for re-entry to Great Britain.
- You are responsible for checking the accuracy of the certificate that you will be given and also for checking any further entry requirements of any destination countries.

We also recommend researching local parasites (e.g. ticks or sandflies) in your destination country and contacting us for further advice should you need any preventative treatment for these.

IMPORTANT DOCUMENTS

It is imperative that you bring the following documentation to your appointment:

- Proof of vaccination against rabies – *this can be a vaccination card or previous pet passport*
- Proof of microchipping – *this can be a vaccination card or previous pet passport or your original microchip documents*

Please contact us in advance of your appointment if you are unsure about this documentation.

When you attend your appointment, your pet will have a health check with one of our OVs and they will check your pet's microchip number and rabies vaccination details.

Please make sure that you remember to bring the necessary documents mentioned above, as copies will need to be made of these to be included in the completed AHC.

We will ask you to sign the declaration to say that you will be travelling with your pet.

Depending on when you are travelling and the time of your appointment, you may be asked to leave and return later (or on another day) to collect your completed AHC as these documents take time and require care to complete accurately.

Failure to attend an AHC appointment with less than 24 hours' notice will incur a £100 cancellation fee as our OVs do a lot of preparatory paperwork prior to your visit.
