## Animal Health and Welfare Pathway -Funding Update



The pathway was first launched back in February 2023. It aims to improve farm animal health and welfare by providing funding for farmers to support disease investigation. The funding can be used for an annual vet visit to review biosecurity and medicines usage, carry out diagnostic testing and provide advice.

The review is available for farmers who have 11 or more cattle or 21 or more sheep. The initial funding focusses on Bovine Viral Diarrhoea (BVD) in cattle and parasite testing including anthelmintic efficacy in sheep. The following funding is available:

Further support has been launched in June 2024 to allow farmers to build on actions taken from the initial review or to address other diseases on the farm. The follow up review must be completed no more than 10 months after the initial AHWP review. This follow up round of funding is currently available for beef and sheep holdings.

#### **Beef cattle**

Further testing for beef cattle continues to focus on BVD. If the initial AHWP testing was negative for BVD, the follow up should focus on biosecurity. This will include assessing farm boundaries, stock movement, cleaning, vaccination and the BVD Free accreditation program.

If the initial test was positive for BVD, a focused biosecurity assessment should be completed and further testing for persistently infected cattle in the herd through blood or tissue sampling should be performed.

#### Sheep

Further testing for sheep focusses on a wider range of diseases. Funding can be provided for one or multiple conditions from several categories including ewe health, reproductive performance, lamb performance, neonatal lamb survival, external parasites and lameness. The funding should be used for appropriate disease sampling and to review biosecurity and medicine usage.

### **Bovine Respiratory Disease**


Bovine respiratory disease (BRD) or pneumonia is the most common reason for death and poor performance in young cattle and costs the UK cattle industry an estimated £50 million a year (source: AHDB). As we head towards the housing season we encourage you to start thinking about how this might impact your herd.
