The stallion must not be used for covering or semen collection for 30 days prior to entry at OVH

Blood Tests and swabs – These must be taken no more than 20 days before entry to Oakham Veterinary Hospital. They must be sent to the following labs for testing.

EVA & EIA blood tests **must be sent to VLA Weybridge, New Haw, Addlestone, Surrey, KT15 5NB
CEM swabs **must be sent to VLA, Rougham Hill, Bury St Edmunds, Suffolk, IP33 2RX****

Please note – due to DEFRA rules changes 2 CEM swabs must be taken **exactly** 7 days apart if semen is for export to the EU. Both tests must be the four sites test which includes Penis, Urethra, Urethral Fossa and pre ejaculatory fluid.

Vaccinations

Equine Influenza and tetanus vaccinations **must** be up to date. If a stallion is EVA vaccinated the vaccinations must be up to date and recorded accurately in the horses passport. A pre vaccination negative blood result is also required.
