# Cats and your lifestyle questionnaire

Getting a cat can mean different things to different people. Some are happy with a cat which spends all its time outside and is very independent whilst others prefer an indoor lap cat.

There are some key areas to think about before getting a cat.

#### Environment

Do you live:

- Near a busy road? (I)
- Near a fairly busy road or in a flat/apartment? (2)
- On a quiet street/cul-de-sac? (3)

#### Time

- Are you out of the house most of the day and evenings? (1)
- Are you out most of the day but at home a lot outside of working hours? (2)
- Do you have lots of free time? (3)

# How much are you willing to spend on your cat? (food, medications, insurance)

- 🐇 £80 £120 per month (2)
- £120+ per month (3)

#### Do you have other pets?

- Lots of other pets including cats and dogs that don't get on (I)
- No pets (2)
- Friendly pets that socialise well with other animals (3)

Please note this is a rough guide to give you an idea of the type of cat will suit you, we understand there are varying factors and each owners circumstances will be different.

Is your home suitable for a cat?

- **4 7** = Your lifestyle may not be suitable at this time based on your living situation and estimated expenses. We can discuss changes with you that would allow you to have a cat.
- **8 II** = An indoor cat may be more appropriate based on your living situation.
- **12** = Your lifestyle is appropriate for getting a cat!

# Getting a new kitten Vs a rescue cat

There are many factors to consider when thinking of getting a new cat such as the environment it will be living in, as well as budgeting for food, medications and insurance, amongst other things. It's also important to manage your own expectations as to what you want from a feline companion in order to get the right one for you and your lifestyle.

Being ready to accept any new cat in to your home is vitally important. Having everything you need ready will help provide a stress free transition. Food and water bowls, litter trays, toys and a comfy place for them to sleep are all necessary items when it comes to settling in.

#### Getting a new kitten

There are different places you can get a kitten from, either from a breeder, a rehoming centre or a friend/neighbour. If possible it's best to see the kitten with their mother so you can get an idea if there are any health concerns right away. There are still some breeders that don't keep their animals in suitable conditions so don't be afraid to walk away if you don't like what you see.

#### Cost of a new kitten

Depending on the breed/breeder, getting a new kitten can be expensive, and people are then reluctant to spend more on necessary veterinary treatment, insurance etc. Make sure you have the funds available and take advantage of the 4 weeks free insurance offered by Petplan to all new pets.

# Benefits to getting a cat from a rehoming centre

There are many charities out there which specialise in rehoming cats of all ages and breeds which means finding the right cat for you may be easier than you think.

- The rescue centre will have ensured that the cat has had a full health check and you will be informed of any medical conditions upfront
- All cats will have been vaccinated, treated against fleas and worms and be spayed or neutered if appropriate before the adoption. Some may charge a nominal fee to cover these costs
  - Most rehoming centres will be able to provide advice on how to best look after each cat that is up for adoption

#### Getting a rescue cat

People are often put off by the prospect of getting a rescue cat due to uncertain histories (an important consideration with young children) the challenge of re-socialising, or simply because they want to enjoy the 'kitten phase' of cat ownership. However, it is incredibly rewarding and there are many other benefits to rescuing a cat.

 You are giving them a second chance! They have ended up in a rescue centre through no fault of their own and with the right owner can become the loving, family cat that they deserve to be!

- Adult cats can require less maintenance than kittens as they are usually very independent and selfsufficient already, however most will definitely love attention!
- There are usually different breeds to choose from which means you are able to find one that will be most suitable for you

 The initial costs of rescuing are far lower than obtaining a new kitten from a breeder

#### There can be challenges in rescuing a cat

### **Essentials for your new cat**

To avoid little accidents all over the house when trained.

#### A small selection of toys

To help relieve boredom. Can help with bonding as well.

#### Cat safe collar

If they will be going outside, a collar is a great way to keep them identified and most will also be reflective if they wander a little too far.



### Feliway pheromone diffuser

Can help cats feel safe and secure in new environments. Especially helpful for re-homed cats and multi cat houses. Feliway especially for re homed cats and multi cat houses.

#### Do your research

There are many different decisions you will have to make when it comes to getting a new kitten. Researching what type of food to feed them and comparing insurance prices are just two

of them. Book a pre-pet consultation with your practice and they will happily run through everything you need to know to get you ready.

#### Plan ahead

Setting your home up in advance of your new arrival will help provide a less stressful transition. This includes setting up a safe place for them to settle into and providing clean and comfy bedding with free access to water close by. It's also recommended to move anything breakable from the immediate area as a new kitten will be keen to explore their new surrounding when they feel more comfortable. Keeping them away from any other pets in the house for the first few weeks is also advisable to avoid any unnecessary stresses, gradually exposing them to each other over time.

#### Insurance

We will always recommend getting pet insurance, it acts as a bit of 'safety net' for unexpected veterinary fees. Providing your new cat/kitten doesn't have any pre-existing conditions, they should receive an adequate level of cover, and we do also recommend getting 'COVER FOR LIFE', which means your pet's condition will always be covered, should they suffer from a condition that requires life-long medication (some policies are only per year).

#### Animal Welfare Act 2006

All cats whether owned or feral are covered under the Animal Welfare Act 2006.


#### **ENVIRONMENT**
